Report on Springposium 2010

Patent, Trademark and Copyright attorneys once again gathered a few months ago on May 7-8, 2010, for the 6th Annual SpringPosium® IP CLE Conference at Barnsley Gardens Resort in Adairsville, Georgia. Cobb County Bar Association Board of Trustees member Jeff Kuester of Taylor English Duma presented the Patent Law Update, continuing his record of making a presentation at every Conference since it began in 2005.

The patent update included a short discussion about the Bilski v. Kappos case at the U.S. Supreme Court, which dealt with determining the limits of patentable subject matter for computer software and business methods. Jeff had special interest in the case because he represented the inventors (Bernie Bilski and Rand Warsaw) and attended the oral arguments with the inventors in Washington, DC. While the Court ultimately held that there was no categorical exclusion from patentability for business methods, the claims at issue were considered nonstatutory because they were characterized as merely claiming an "abstract idea" limited to a particular field of

use. Consequently, while business methods are still patentable, greater care must be taken to properly characterize them. The patent update also focused on the heightened risks of design patent invalidity, tightening requirements for proving patent damages, continued clarification of declaratory judgment jurisdiction, expansion of infringement by inducement through deliberate indifference, a false marking explosion, and expanding written description requirements. Other topics included a trademark update, effective use of experts in intellectual property cases, Internet/domain name update, and intellectual property licensing developments.
